Adjusting to a New Normal


It appears that southeastern Michigan will soon have many of the state-imposed restrictions lifted that had been put in place to protect residents from the COVID-19 pandemic.

AA acquitted ourselves admirably during the lockdown, quickly migrating from face-to-face meetings to virtual meetings and actively publicizing them. Many members actually found themselves participating in more meetings during the lockdown rather than fewer.

It behooves groups to return to our traditional meetings in a considered and thoughtful way.

- Don't assume that, once the lockdown on public gatherings is lifted, groups are automatically entitled to return to our normal venues. Whether to re-open a church or other facility to AA meetings is the decision of that facility, not that of the AA group(s) that have met there in the past. Go through the channels.
- If the facility stipulates restrictions, abide by those. Masks, social distancing, bans on food or drink—all of these (even coffee) are peripheral to AA's central mission of carrying the message of recovery.
- Are AA groups obligated to pay rent for a meeting place during the time when it was inaccessible to groups? That needs to be worked out between the groups and the facilitv's managers.
- Many groups periodically make distributions from their treasury to other AA entities-the General Service Office in New York, the AA of Southeastern Michigan Service Office in Ferndale and/or the AA of Oakland County Service Office in Pontiac, the Area 33 of Alcoholics Anonymous office in Southfield, and the group's home district. For the most part, AA groups in Michigan haven't passed collection baskets in three months. Group treasuries are likely to be tight when the next round of distributions is being made. Accordingly, groups might want to consider taking up special retroactive collections specifically for distribution purposes.
- If your group is resuming face-to-face meetings, let the

But without the availability of virtual meetings, I don't know how I would have made it through these months.

Being an alcoholic, I tend only to think of myself. I forget that, even in the absence of a public health crisis, there are homebound alcoholics trying to stay sober one day at a time.

Though I shouldn't speak on their behalf, I'm willing to bet that the faithful servants of the <u>Area 33</u>

Accessibilities Committee are closely looking at this issue.
