There was a beautifully decorated chocolate cake on one of the two tables that were set up. It read, "Welcome!". As the meeting start time came, there was still just the three of us. I inquired as to whether this was just a slow time of the season, due to it being Fall? "No", they said, "The most we ever have is five or so". I thought, "What a waste of time. The money I placed in the basket would certainly not even pay for the cake, much less the few pieces of literature displayed."

We started the Open Meeting, as all Detroit Metro meetings start, with the Serenity Prayer and the readings. I was given two to read, the couple read the others. I was still feeling like this was a waste of time. However, as the meeting progressed and we started sharing, my scrutiny of the little meeting melted like butter in the sun. And, at the end of the meeting, we enjoyed pieces of delicious cake and talked some more. I was there for hours.

I personally have sat in the parking lot drinking and searching for the strength to walk into the meeting. Some days I was drunk and had booze on my breath but was able to go in. Every time drunk or not, I was hurting and looking for the solution. Every time I was welcomed and thanked for my share. When leaving it was clear I would be welcomed back. Years before attaining sobriety A.A. was a safe place for me, no matter what I had done, what I did for alcohol and how lost I was. I was a welcomed member of A.A. years before I was ready for sobriety.

As a young man in 1992 in my first round with A.A. at my first meeting ever another member looked at me after I shared and said "I've spilled more liquor than you drank". At the time he may have been right. I have heard the saying "an alcoholic hits bottom when he stops digging". Who is to say where our bottom is? Each individual member is for themselves. Even the judge who sends some of us to meetings can not make us 'buy in' nor ought we discourage other members from attending. The Twelve and Twelve tells us "we are not afraid of you, no matter what you have done".

#### 3nd Step

"Therefore, we who are alcoholics can consider ourselves fortunate indeed. Each of us has had his own near-fatal encounter with the juggernaut of self-will, and has suffered enough under its weight to be willing to look for something better." Twelve and Twelve PG 37-38

As a drinking alcoholic my self will was the only way. Every morning I woke with the honest intent not to drink. Then I would just have one, and like that, I was off to the races yet again. My will led me further down the rabbit hole of pain and despair. Every day was spent trying to fill the hole in my soul. During my earlier days in A.A. I followed the path described as often taken in the Twelve and Twelve and trusted in a sober A.A. friend. My sponsor became a power greater than myself simply because he was a voice of reason I was able to listen to. It was not until I made continued and focused attempts to pray and meditate that the guidance of my Higher Power became an active part of my recovery. A big issue I struggled with was having a clear vision of God. It was not until I gave up on the need to picture the "man in the sky" and simply listened for the care of God that I was able to trust in. Starting with the 'Gift Of Desperation' and then a 'Group Of Drunks' what I realize now looking back is that my Higher Power has always been there for me to trust in. For me step three is simply making the decision to not try my own will power anymore and to trust His will, not mine.
